SUBJECT: Topaz Lake Concerns by Topaz Lake Homeowners' Association

We, the undersigned members of the Topaz Lake Homeowners' Association, have great concern about the safety and sanitation around the lake.

We continue to struggle with the problem of transients and vacationers using the beaches of Topaz Lake improperly. In the event of misuse of the property resulting in Iliness, accidents, or fire, the result could become a very complicated liability issue, and could be very expensive to the WRID, the county, and very possibly to individual homeowners. This issue has been troubling for years, and we want to resolve it.

We request the assistance of Douglas County and WRID in helping us maintain a clean and safe shoreline.

We ask for your cooperation in putting up signs warning against campfires, against overnight camping, and against defecating and leaving trash along the lake.

We are willing to help fund some of the signs if the WRID will place them properly along their property. When proper signage is thus present, we request the Sheriff's Department to respond to complaints of residents and day-users to warn and remove those people who have become a threat to the health and safety of all who enjoy the recreation of the lake or who live around the lake.

Examples of requested signage:

- -Day Use Only/No Overnight Camping
- -No Open Fires
- -Remove Trash & Pet Waste
- -No Firearms or Fireworks

Additional signage is needed for county easement leading to the lake at the corner of Comstock Drive and Kit Carson Road:

-Foot Traffic Only/Emergency Vehicles Only
